Using the Logo Guidelines

If you are planning an event or activity for IDPwD, you can use the logo to create your own promotional materials.

You don't need to seek approval to use the logo or credit IDPwD, as long as you follow these principles:

- Your event and/or activity is consistent with the aims and messages of IDPwD and helps to raise awareness of disability inclusion.
- The IDPwD logo is used for non-commercial purposes.
- You follow the logo guidelines outlined in this document.

Using the IDPwD logo

There are four versions of the IDPwD logo:

- The standard and stacked logos can be used on a white or light coloured background
- The standard (reversed) and stacked (reversed) logo can be used on a blue background.
- The IDPwD logo should not be re-designed, altered or cropped.
- All elements of the IDPwD logo must be used.
- Allow a 5mm exclusion zone around the logo.

- Accessibility consideration:
It is important to have a good contrast between the background and text and/or imagery.

Frequently asked questions

1. Do I need to ask permission to use the logo or credit IDPwD?

No. You don't need to seek approval to use the logo or credit IDPwD, as long as you follow these principles:

- Your event and/or activity is consistent with the aims and messages of IDPwD and helps to raise awareness of disability inclusion.
- The IDPwD logo is used for non-commercial purposes.
- You follow the logo guidelines outlined in this document.

2. Can the IDPwD logo be used for commercial purposes?

No. The IDPwD logo is licenced under an **Attribution-NonCommercial-NoDerivatives 4.0 International** Licence.

This means:

- You can use, share and redistribute the IDPwD logo in any medium or format.
- You can't use the IDPwD logo for commercial purposes.
- You can't remix, transform or build upon the IDPwD logo.

3. Can I use the IDPwD logo throughout the year, or is it just for 3 December?

Yes. You can use the IDPwD logo throughout the year.

While IDPwD is recognised on 3 December, you are welcome to use the IDPwD logo to promote messages of disability inclusion year-round.
